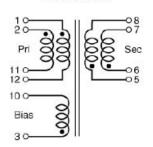








SCHEMATIC


